MENTORING CELL

As per ASCET the composition of the Mentoring Cell

- ✓ Students volunteering as mentors for the freshers
- ✓ Many levels of tiers and mentors
- ✓ One mentor for six freshers
- ✓ One mentor of higher level for six mentors of lower level
- ✓ One faculty member for a group of higher level mentors

Roles and Responsibilities of committees

1. **Junior Level:** To mentor freshers, to interact with freshers and to provide congenial and welcoming environment on the campus. There will be around 60 freshers, so there has to be 10 mentors of junior level.

2. **Senior Level:** To guide and support as well as to interact with freshers through junior level mentors. As there are 10 junior level mentors, so two senior level mentors will help them.

Punishable ingredients of Ragging:-

- Abetment of Ragging;
- Criminal conspiracy to rag;
- Unlawful assembly and rioting while ragging;
- Public nuisance created during ragging;
- Violation of decency and morals through ragging;
- Injury to body , causing hurt or grievous hurt;
- Wrongful restraint;
- Wrongful confinement;
- Use of Criminal force;
- Assault as well as sexual offences or unnatural offences;
- Extortion;
- Criminal trespass;
- Offences against property;
- Criminal intimidation;
- Attempts to commit any or all of the above mentioned offences against the victim(s);
- Physical or psychological humiliation;
- All other offences following from the definition of “Ragging”.
